Load-in: Load-in will be Thursday from 12noon-8pm. Do not arrive early. Vendor participants will receive a packet of instructions. There will be limited load-in on Friday morning from 8am-9:30am. **___ I will come Friday morning.**

Media rights: Vendor agrees to allow Festival to photograph or record Vendor's activities and permits use of such photographs or recordings for promotional purposes.

Liability: Vendor agrees to indemnify and hold Festival, Ocean Shores/North Beach Chamber of Commerce, City of Ocean Shores, and any associated organizations harmless from any and all losses, claims, actions, damages and expenses arising out of its performance or lack of performance under this Contract. Vendor assumes all risk of loss or damage to Vendor's property at any time while on Festival grounds.

Right to disapprove merchandise: Festival reserves the right at its sole discretion to prohibit the sale of any product that is unsafe; that portrays Festival or any aspect thereof in an incorrect or misleading manner; or is inappropriate or unseemly to a family-oriented event such as the Festival. OSNBCC shall have sole discretion to reject, eject, or withdraw any vendor from the show at any time.

Protection of property: Festival insurance does not cover supplies, equipment or materials related to the activities or services of the Vendor.

Due Date: Applications must be postmarked by Friday March 22, 2019. Late applications will be considered if space is available.
